Domestic excavator sales +99% YoY in Feb a surprise

China Construction Machinery Association (CCMA) released surprisingly strong earth-moving machinery sales data for Feb. Domestic sales of excavators / wheel loaders surged 99%/63% YoY, not only helped by the CNY base effect but, more importantly, also the stronger-than-expected actual demand. We believe the recent supportive macro policy has gradually translated into actual demand, with earth-moving machinery being the first to recover in the project-level cycle. We maintain our view that the upcycle of replacement demand will boost earth-moving machinery sales this year. In the near-term, the traditional peak season in Mar will likely further boost the sector sentiment. Reiterate BUY on SANY Heavy (600031 CH), Jiangsu Hengli (601100 CH) and Zoomlion (1157 HK / 000157 CH).

- Excavator sales +53% YoY in Feb. Domestic sales surged 99% to 11.6k units. Exports grew 13% YoY to 7.6k units. In 2M25 (CNY effect eliminated), total excavator sales grew 27% (domestic: +51%; export: +7%).
- Wheel loader sales +34% YoY in Feb. Domestic sales surged 63% YoY to 4.5k units. Exports grew 13% YoY to 4.2k units. Electric wheel loader sales volume reached 1.3k units (+3.4x YoY), representing 15.2% of the total wheel loader sales (up from 4.6% a year earlier). In 2M25, total wheel loader sales grew 17% YoY (domestic: +26%; export: +8%).
- The sales data for other construction machinery will be released by CCMA later this month.






Figure 1: Monthly excavator sales in China





Figure 3: Komatsu excavator monthly utilisation hours in China





Figure 5: Komatsu excavator monthly utilisation hours in Indonesia





Figure 2: Monthly excavator export volume






Figure 6: CMBIGM excavator sales projection




Figure 7: CMBI excavator sales projection (breakdown by region)





Figure 8: Monthly wheel loader sales in China





Figure 9: Monthly wheel loader export volume




